RES NO. 1 During Confirmation of previous
proceedings, the Gram Sabha raised
an objection over non-compliance of
issuing Stop notice for the proposed work of
Sub div of plots in property Sy No. 57/2 of
Village Chimbhel and now once again
Gram Sabha resolved to revoke provisional
NOC issued to Smt. Pooj Dabai and others
for the proposed Sub-div of plots in
property Sy No. 57/2 of village Chimbhel
on the basis of following discrepancy/
grounds:-

- 1) The open spaces, Length of the Roads
are not properly shown on approved plan
- 2) Panchayat has issued NOC based on
the TCP approval and neither Panchayat
nor TCP department has verified approved
plan physically on site.
- 3) on the approved plan 10.00 mtrs. existing
road shown, which is wrong as there is
no existing 10.00 mtrs. road, the same
road is shown as proposed 10.00 mtr
road in the regional plan 2021.
- 4) There are already few existing constructions

Before the Gram Sabha Meeting, was discussed and approved as under:-

1) Garbage: The Sarpanch assured that the necessary fines will be imposed on the culprit throwing Garbage and also informed the Gram Sabha members regarding throwing of Chicken waste at various places, Sarpanch also informed that the necessary meeting with Chicken shop vendors already conducted and they are in process of signing agreements with Chicken waste collector which is pending due to finalisation of amount of fees/charges.


2) Nallahs: The Sarpanch informed the Gram Sabha as per records Nallah details are not available with panchayat and cleaning of Nallahs not done by the panchayat as it cost huge amount and assured that necessary information of Nallahs will be made available through WRD and also request them to carry out desilting of Nallahs within the jurisdiction of panchayat.

3) FDA check-ups of all stores and shops: Sarpanch informed the Gram Sabha that FDA inspection along with health and panchayat will be carried out on Monday 4th August 2025 from 10:30 am onwards. If any one wants to join then they are allowed to join the said inspection.

4) No parking Zone, Roads & Sign boards matters: It was informed by the Gram Sabha members and Graciously that No parking Zone is not

Further Gram Sabha resolved to oppose any kind of construction activity around Toyar Lake as it will have direct impact on the flow of water/drainage channels into the lake and eventually will dry up the lake, as the case is pending before in the High Court of Bombay or Goa that no development activity is to be carried out in Sy No. 40/1 and 40/3 in village Chimbhel without informing the Court, Gram Sabha also demand & resolves that area falling outside of the notified wetland area of Toyar Lake i.e. Sy No. 40/1 (part), 41/1 (part), 40/3, 42/1 (part) and 106/1 in Telavim village be declared as a Biodiversity Park, which will help with, serve as filters for point and non point source of air pollutants, Reduce flood water velocity, promote ecotourism, purify water, enhance biological productivity, sustains river ecosystem and Rejuvenate rivers etc.

Finally Gram Sabha unanimously resolved to strongly oppose any construction activity around Toyar Lake in Chimbhel village and not to issue any construction license for mega projects within the jurisdiction of V.P. Chimbhel.

Since there was no any subject on the Gram Sabha matter to discuss the said meeting is concluded at 2:15 pm.
